SEND: Now and Moving Forwards Together Event

This information will feed into the local area's self-evaluation and will be crucial in our action planning as we move forward.

SENCo Quadrant Meetings Updates

(Following feedback, we are sharing a short update for each quadrant)

North: Discussion - Questions were raised regarding LA departments/units and how Ofsted inspects these. SEND Team to consider offering further

information/training regarding how tribunals work and school's role within these, including if called to be a witness.

East: Transition Activity – It was discussed that a shared template to complete for Secondary school transition would be helpful. SEND Team to locate a copy of what had been worked on in previous times

South: Transition activity - Questions were raised regarding ideas for improving transition processes including the transition of pupils starting special school and mainstream secondary school. Further links between secondary schools and primary schools to be established.

West: Transition Offer - The quadrant agreed that the EYs to primary transition was strong and well supported by the specialist teaching team and felt that further work could be done to strengthen the primary to secondary and the Year 11 to post 16 transitions. It was also discussed about clarification of processes and expectations regarding annual reviews.

Thank you to our fantastic SENCo co-chairs who will continue in their role into the first half of the autumn role where agreed.

A special education SEND update newsletter will be shared at the beginning of term to highlight the agenda items for discussion and consideration during the autumn term 2023.



Assessment Team Updates

The EHC needs assessment process is a 20 week legal process which continues throughout all holiday periods. Due to this we would like to highlight that the Assessment Team will be continuing to make decisions to assess and issue during the summer holidays. In person forums will not take place but will instead be paper based exercises, therefore please consider any requests that you may be making as a SENCO prior to the holiday period and ensure that paperwork offers a full picture of the child or young person. Please also remember should you refer to an EP consultation or Specialist Teacher report within your paperwork then please include it. As a team we may hold these documents on file however if it isn't included in the paperwork we cannot share it with professionals as part of the request.

As an Assessment Team we are able to apply a 4 week exception to some cases where the assessment period falls within the holiday period. This will be applied as required and information shared with families and school as appropriate.

As a team over the summer holiday period we will still share decisions made with schools and there may be planning meetings held, however we do not expect schools to attend these. As a school you can feed in to the draft 2 plan, the assessment officers have a sound understanding of the provisions within their schools and use this knowledge along with the SEN support plan and evidence gathered as part of the assessment process to formulate the draft 2 plan.

If parents or other professionals make a request for an EHC needs assessment we will need to make a decision to ensure we are within legal timeframes. We understand that we may not have information from school but will make our decision based on the information received.

As an LA team we have reviewed the feedback received from schools with regards to the forum process and will be setting ourselves some actions to improve the forum process for all involved.

One of the points raised was that schools like the forum being held in other schools, as this provides an opportunity to visit other settings and an insight in to how they operate, always useful in terms of CPD! As an LA we are looking for schools to host forum. If you have a space to offer for a term, we would love to hear from you.

We would require; a room that can host up to 20 adults, WiFi connection, access to refreshments (hot water and cups, we bring our own tea-bags etc), toilets.

EHC Audits

EHC audit meetings take place monthly at Civic Offices, with representatives from schools, Children's Social Care, Health as well as the EHC Specialist Teaching Team, Review and Assessment Team. Recent meetings have focussed on auditing new EHCPs and have identified the following strengths and areas for improvement:

Strengths

- Smart short-term outcomes
- References to reports from professionals are numbered clearly
- Voice of parent and child is clearly heard throughout the EHCP

Areas for Improvement

- Background and summary should summarise the needs and history. This doesn't need to be lengthy
- Preparation for Adulthood can be a weak area it needs to be completed from Year 9 onwards
- Long term and short-term outcomes need to link
- Outcomes and Provision: there needs to be a clear distinction between outcomes and provision. Provision needs to be concise. Quality First Teaching strategies don't need to be included in provision

Future advice and training will link to these areas for improvement. The next review cycle will focus on recently reviewed EHCPs.

SEND Support Line

The SEND Support Line has continued to be used consistently by our settings/schools, professionals and parents/carers this academic year. To date, we have received over 4,500 enquiries, with an average of over 440 enquires responded to every month. 40% of enquiries received are from parents and carers and the main area of need that we receive enquiries about is communication and

interaction. Although we allow 5 days to respond, 97% of enquires are responded to within 2 working days.

Opportunity for schools to provide places for children with Autistic Spectrum Condition (ASC) from 2024

The expression of interest for schools who want to provide additional places for pupils with ASC from 2024 as part of a department/unit within a school closes on 14 July and we want to thank our schools for submitting their interest.

We will be providing further updates in the autumn term.

Centralised Training Update

This year nearly 700 setting and school staff in more than half of MK primary schools and nearly 75% of secondary schools have accessed our centralised training offer. More than 400 feedback responses were received, with 85% of attendees reporting that attending the sessions had led to improved knowledge and 96% feeling that they were able to improve their practice. This indicates the significant positive impact the sessions have had for our settings and schools to effectively support and include CYP with SEND.

Our new centralised training booklet will be available by the 1st September, a link to the document when released will be available on the Local Offer.
