Worrying or anxiety is a normal feeling that we all experience from time to time. It can even keep us safe from harm or help us perform in difficult situations. However, sometimes anxiety or excessive worrying can become a problem especially when it stops people doing what they want or need to do. Many children and young people worry about school. This is normal. Anxieties are part of life and learning to deal with them is part of growing up. However sometimes a child's worries may lead to difficulties attending school. If your child has high levels of anxiety and does not want to attend school, they may be experiencing Emotionally Based School Avoidance (EBSA). (Credit West

## **SENCo Quadrant Meetings Updates**

(Following feedback, we are sharing a short update for each quadrant)

During the meetings, reviewed guidelines to assess and guidelines to review EHC's were discussed. Across all four quadrants positive feedback for the documents was received. Additional feedback from the quadrants is shared below:

**North**: Themes during the meeting were around higher levels of need transitioning into school. Further work was identified with EY settings to highlight needs to receiving schools and to ensure external agency support has been sought.

**East:** Colleagues shared some transition ideas that had worked well, including an after-school transition club which had met each week after school in the second half of the summer term.

**South:** Colleagues shared that increasing numbers of children are starting school for the first time with significant needs. Colleagues discussed how they can support one another and suggestions were made for how this could be approached.

**West:** Transition from Early Years and early identification of needs was discussed in the meeting. It also came up about support for SENCo wellbeing and a discussion was had about whether supervision could be a supportive way forward.

#### **Specialist Teaching Team Updates**

#### **Top Up Funding**

Schools and academies should have sufficient funding in their delegated SEN funding budget to enable them to support the majority of pupils' SEND where required, up to the nationally agreed cost threshold of £6,000 per pupil. Where individual pupils require additional support that costs more than £6,000, the extra costs can be met by requesting Element 3 funding for the individual pupil. Top Up funding is intended to provide additional, individually targeted support for named pupils who have a range of complex special educational needs whilst remaining in mainstream schools. Top-up funding is provided where these needs, and the provision required to meet them,

We have recently updated our SEND Local Offer with <u>Top Up Funding Guidelines</u>. For all Top Up Funding requests, an application form should now be completed found in the above link.

#### **SEND Team Request for Involvement**

All requests for involvement from the Specialist Teaching Team (SST) or Educational Psychology Service (EPS), must be discussed via an initial conversation between the SENCo and SEND Support Line. The SEND Support Line will advise and triage all enquiries to ensure that the most appropriate support is given at the right time. Support may include initial advice from the SEND Support Line to add to an assess, plan, do review cycle.

Where it is agreed that the STT or EPS will be involved, the SEND Support Line will provide the relevant forms for the SENCo to complete.

For Specialist Teaching Team involvement for CYP with SEND Support Plans or EHCPs, you will be asked to complete a 'Request for involvement form'. All parts of this form alongside identified additional information **must** be submitted for the request to be considered for allocation.

Ordinarily CYP at the SEND Support Stage would need to have a SEND Support Plan in place and at least 2 cycles of APDR before specialist teacher involvement would be considered.

#### **Assessment Team Updates**

Coming soon: EHC Needs Assessment Guidelines

During the Summer term, we worked with representatives from SENDIAS, education, health and social care to review our current EHC needs assessment guidelines. Our new coproduced EHC needs assessment guidelines will be shared in the coming weeks on our Local Offer Pages. The guidelines aim to support

professionals and parent/carers understanding of the EHC needs assessment process to ensure that requests are being made at the right time.

#### **Review Team Updates**

From 30 October 2023, there will be a move from our current allocation for Review and Placements Officers, from the current North, Central and South areas, to quadrants in line with our Heads and SENCos quadrants. This will enable a more even distribution of schools and caseloads for our officers. Review officers for our special schools will remain the same. Further information will be emailed to SENCos next week.

Updated 2023 - 2024 Annual Review Guidance and Templates will be available on the Local Offer, along with the 2023 - 2024 Annual Review Report. Any previous guidance and templates should not be used after this date.

The Annual Review report must be completed and returned to <u>EHCP@milton-keynes.gov.uk</u> with the recommended amendments within 2 weeks of the review meeting. If there are any queries regarding the new guidance please contact the EHCP mailbox, as above.

#### **Educational Psychology Service Update**

We have recently recruited an interim Principal EP, Jane Marriott and a Senior Leadership EP, Hayley Prickett who will be starting with us after the half term. The team is comprised a mix of permanently appointed EPs and a number of associate locum EPs at this time. Where an EHC assessment has been agreed for a CYP, adjustments in MK have mirrored national adjustments to support the assessment process being conducted in a timely way using a variety of methods and this includes the use of remote assessment.

Access to EP support is available to schools via the SEND Support Line where you can book a consultation slot. You will need written parental support before the consultation can go ahead.

If a different type of EP support is needed, schools should contact the SEND Support Line and complete a form requesting SEND and Inclusion support. The Educational Psychology Service will only become involved where psychology involvement is considered necessary and appropriate. We will prioritise requests for individual involvement where a child or young person meets one or more vulnerability criteria listed on the <u>SEND Support offer</u> on the Local Offer.

## **EHC Audits**

The first EHC multi agency audit of this academic year took place in September which focussed on new EHCPs for CYP with SEMH difficulties.

#### Strengths

- Strengths were consistent across the EHCPs and have improved since the start of the auditing process last year
- Section B is clear and concise
- SENCos and teachers would be able to put provision in place quickly and easily
- All key information is provided

Areas for development

We need to ensure that the voices of all professionals are heard in the plan

- Quality First Teaching strategies shouldn't be included in provision
- Outcomes don't always link to the difficulties in Section B



## **MK Deal**

MK Deal is the local health partnership in Milton Keynes bringing together Milton Keynes City Council, the local NHS and the voluntary sector. One of its programmes is improving Children and Young Peoples (CYP) Mental Health in

Milton Keynes. The programme has identified 4 key goals, one of which is **Joining up the training on Neurodevelopmental Pathways.** 

A huge thankyou to all the schools to completed the questionnaire on training in schools for Autism Spectrum Conditions (ASC) shared at the beginning of the Autumn term.

A working group has been established, led by Victoria Courtis (MKCC SEND Lead) and Vicky Hancock (Deputy Service Director for MK CAMHS) to identify the training that will be delivered to the Special Educational Needs Co-ordinators (SENCo's) for Autism Spectrum Condition (ASC), and the outcomes to be achieved from its delivery. The working group would greatly benefit from your contribution and views.
